HS Eliminating Disparities & HS Enhanced: Any organization currently funded with a federal Eliminating Disparities or Healthy Start-Enhanced grant.

HS Catalyst IHE: Any organization currently funded with a federal Catalyst for Infant Health Equity grant.

Organizations – For Profit/Corporations: Any for-profit business/company/corporation with an interest in or focus on MCH issues and/or father involvement.

Organizations – Non-profit/Government: Any non-profit organization (e.g., a 501 (c) (3) tax-exempt organization) or government entity (e.g., state health department, local municipal government) with an interest in or focus on MCH issues and/or father involvement.

Individual: A person with an interest in MCH issues and/or father involvement who is not joining as a member of an organization and is not a Student or Previous Participant.
